Code 982 Treasury Code : MDI00 in the revenue Head 0070-60-800-17-EPROCUREMENT OF TENDER FEE. The scanned copies of it shall be uploaded under cover-I & the original copies shall be submitted enclosed with the bids.
- b) The intending bidders are required to pay the refundable EMD/bid security (INR 18500/-) in the form of TDR/FDR from a commercial bank separately pledged in favour of District Project Officer, IDP, Mandi, HP. The scanned copies of it shall be uploaded under cover-I & the original copies shall be submitted enclosed with the bids.

- b) The interested bidder must be registered with Integrated Development Project H.P Forest Department as a contractor and he may consult the o/o under mentioned for any details as the case may be.
- c) Thebidsofthecontractors/firmswhofailtofulfilltheeligibilitycriteriawillsummarilybe rejected.Similarly, if the technical bid is not found suitable at the time of scrutiny by the tendering committee, the bid shall be rejected andthustheirFinancialBidshallnot be considered.
- d) Entire tender process will be carried out online through above mentioned website. Contractors /firms are advised to procure e-Token/Digital signing certificate from suitable venders or from any authorized agency.
- e) Before submission of on-line Bids, Bidders must ensure that scanned copies of all necessary document shave been uploaded with the bid.
