**"AUCTION NOTICE"**


**Subject: Disposal of condemned Government Vehicles-Reg.**

Office of the DPO, IDP, Mandi is proposing to dispose off Govt. Vehicle on "as is where is basis". Detail of the said vehicle is as under:

2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mention below. Persons/ firms, interested in purchasing the above mentioned vehicle, may submit their highest value quotations, in the enclosed Proforma, in a sealed cover addressed to the undersigned, **latest by 5.00 PM on 15.03.2021 in the office of undersigned**. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of Quotations, which is scheduled for 11.30 AM on 16.03.2021, in the office of the undersigned. The cover should be prominently superscripted with the words "**QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE**"
3. The vehicle shall be available for inspection between 10:00 AM to 5:00 PM on any working day w.e.f. 10.3.2021 to 15.3.2021.
4. **The Auction of the said vehicle shall be governed by the following conditions:-**
  - i. The vehicles shall be auction on "As is where is basis". The auction process will be conducted by the authorized Committee.
  - ii. The bidders are required to pay **Earnest Money of Rs 10000/-** (Rupees Ten thousand only) in shape of FDR/TDR duly pledged in favour of DPO, IDP, Mandi. (payment by cheque or cash shall not be accepted).
  - iii. Quotations received without FDR/TDR towards Earnest Money will not be considered and shall be rejected.
  - vi. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of DPO, IDP, Mandi within 3 working days of the acceptance of the bid.
  - v. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount within stipulated time, the respective vehicle may once again be taken up for re- auction.


- vi. The delivery of the auctioned vehicle shall be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Adhar Card etc. in case of individual and Registration Certificate etc. in case of firms).
- vii. The auctioned vehicle shall have to be removed by the successful bidder within 7 working days of depositing the bid amount, at their own expenses, by way of either submitting the RTO transfer paper or cut chassis no. of the vehicle.
- viii. The vehicle shall be disposed off on "as is where basis is" and no guarantee for its worthiness or quality will be given by this Department.
- ix. This Department will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicles for commercial or any other purpose after sale/ transfer of vehicle.
- x. The successful bidder will also be responsible for getting Registration Certificate of the vehicle and/ or any other documents as required by the RTO, in his name at his own cost, within 5 working days of depositing the bid amount. This office will not be responsible for any lapse on his part in this regard.
- xi. If, the successful bidder wants to scrap the vehicle, then he should submit the cut part of the chassis number to this office immediately, within 5 working days of depositing the bid amount.
- xii. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- xiii. The bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.
- xiv. The undersigned reserves the right to accept or reject any/ all of the quotations without assigning any reason.
