5. You will have to deposit EPF and ESI as per applicable rates and submit the report to this office.
6. It may be ensured that items of work for which you have quoted low rates be got executed in full.
7. Further you are, hereby required to furnish additional Performance security of 3% of total value with in the 15days of award of work in the shape of FDR duly pledged with District Project Officer, IDP, Shimla.
8. The execution of work and its quality control shall be carried out strictly as per specification and as per instructions of APO/Project Staff.
9. The work will be executed under the supervision of FEO and any other authorized officer.

10. All the material will be checked by the APO/Project staff before using it in the work.
