The -tender documents shall be uploaded in two covers system.

Cover-Ishall contains scanned copies of "Eligibility information and Technical Bid". Cover-II shall contain "Financial Bid" on the prescribed form.

Cover-I:-The "Eligibility information and Technical Bid" shall contain Scanned copies of following documents duly uploaded in the bid:

- a) The intending bidders are required to pay the non-refundable tender form fee (INR 500/-) in form of **Demand Draft** payable at **SBI Kullu** or through e-Challan to District Project Officer, Integrated Development Project, Kullu D.D. - b) The intending bidders are required to pay the refundable EMD/bid security (INR 47,000/-) in the form of TDR/FDR from a commercial bank separately pledged in favour of District Project Officer, IDP, Kullu, HP. The scanned copies of it shall be uploaded under cover-I & the original copies shall be submitted enclosed with the bids. There shall be exemption to deposit earnest money to the firms / manufacturer registered with HP Controller of Stores, Director General of Supplies and disposals (DGS&D), Micro and Small Scale Enterprises registered with HP State Store Purchase Organization and HP State Undertakings subject to the condition that they have to quote the approved rates of above items with the organizations mentioned above.
- c) Uploading of scanned copy of PAN and offline submission with cover-I
- d) Uploading of scanned copy of GST registration and offline submission with cover-I
- e) Uploading of scanned copy of Manufacturer or Firm registration and offline submission with cover-I
- f) Uploading of scanned copy of Bank details of the bidder mentioning Name of the Bank, Branch Name, Account Number, IFSC, etc. and offline submission with cover-I
- g) Uploading of scanned copy of Rate of Contract with the organizations mentioned above sub para-b (for taking exemption) and offline submission with cover-I
- h) Uploading of scanned copy of undertaking(Format attached in Tender Document) that I have carefully studied all the terms and conditions stipulated in the contract document before quoting the rates in the BOQ chart and offline submission with cover-I
- Uploading of scanned copy of authorization letter regarding digital signature certificate (DSC) of the person authorized by the registered tenderer.

<u>Cover-II:</u> Shall contain BoQ where contractor will quote his offer for each item in figures and words (INR) by giving total amount of the offer. Contractor shall not insert any additional conditions or other documents in BoQ.

General Instructions for e-tendering:-

- a) The contractor should register himself on website www.hptenders.gov.in and obtain user ID, password, before bidding.
- b) The interested bidder can consult the o/o under mentioned for any details as the case may be.
- c) The bids of the contractors/firms who fail to fulfill the eligibility criteria will summarily be rejected. Similarly, if the technical bid is not found suitable at the time of scrutiny by the tendering committee, the bid shall be rejected and thus their Financial Bid shall not be considered.
- d) Entire tender process will be carried out online through above mentioned website. Suppliers /firms are advised to procure e-Token/Digital signing certificate from suitable venders or from any authorized agency.
