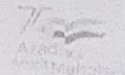

AUCTION NOTICE

Subject :- Disposal of condemned Govt. Vehicle- Reg.

Office of the District Project Officer, Integrated Development Project, Sirmaur at Nahan is proposing to dispose off the Govt. Vehicle No. HP14A-0206 on "as is where is basis". Detail of the said Vehicle is as under :-

2. Accordingly, Open Bids are invited for the disposal of the said Vehicle on the terms and conditions mentioned below. Persons/firms interested in purchasing of above - mentioned Vehicle may participate in the Auction - Sale by **11AM on 15.12.2021 in this office**. The bidders may be present in the bid, which is **scheduled for 11.30 AM on 15.12.2021 in the office of the undersigned**.

3. The auction sale is being conducted on behalf of the Governor of Himachal Pradesh.

4. The Vehicle shall be available for inspection between 10AM to 5PM on any working day.

5. Auction of the said Vehicle shall be governed by the following terms and conditions :-

i). The Vehicle shall be auctioned on "as is where is" basis. The Auction - Sale process will be conducted by the Authorized Committee.

ii). The bidders are required to pay **Earnest Money of Rupees 10,000/-** (Rupees ten thousand only) **in Cash or through Demand Draft** duly pledged in favour of DPO(IDP), Sirmaur at Nahan before the bidding (Payment by Cheque shall not be accepted) which will be refunded to the unsuccessful bidders after completion of the auction sale process.

iii). Bids offered without depositing the Earnest Money shall not be considered and shall be rejected.

iv). No telegraphic offers, private offers and offers made otherwise than the auction place shall be considered.

- v). The bid once made can not be withdrawn. The bidder will not be allowed to withdraw their bids, and if they do so, their Earnest Money will be forfeited.
- vi). No person shall be allowed to participate in this bid at their will unless he has signed terms and conditions of the sale in token of his agreement to abide by him/them.
- vii). The bid shall be lump-sum for the above - Vehicle and the bid once offered can not be withdrawn.
- viii). Road Taxes if any payable after the sale of this Vehicle will be paid by the highest bidder if the sale is sanctioned in his favour.
- ix). No person will be allowed to offer bid on behalf of any other person. Only bid offered in person will be considered.
- x). The Auctioning Authority reserves the right to withdraw the Vehicle from Auction -Sale and the bidder/s will have no objection whatsoever on this account. Any decision of the Auctioning Authority i.e. DPO(IDP), Sirmaur at Nahan who is conducting the Auction Sale of the Vehicle will be final and no Court Case will be filed by any Bidder/s against the DPO(IDP), Sirmaur.
- xi). Objection, If any, about the auction sale or terms and conditions must be submitted in writing before the Auctioning Authority. No objection shall be considered after beginning of the auction sale process.
- xii). The Vehicle shall be disposed off on "as is where is basis" and no guarantee for it's worthless quality will be given by this department. It is presumed that the bidders have inspected the Vehicle and satisfied themselves about the quality and condition of the vehicle.
- xiii). **100 % of the sale - amount of the Vehicle shall have to be deposited by the highest bidder at the fall of the hammer in Cash or in shape of the Demand Draft duly pledged in favour of the DPO(IDP), Sirmaur at Nahan payable at Nahan.** If the bid is not accepted by the Auctioning Authority, this amount will be returned to the bidder without interest. The successful bidder shall also **deposit the balance amount of all the applicable taxes** which will be over and above the sale amount **within Seven working days**, otherwise the Earnest money deposited by him/them will be forfeited and the Vehicle shall be taken up for re- auction. Possession of the Vehicle will be handed over to the successful bidder only after receipt of full sale - amount and taxes as applicable from time to time.
- xiv). The highest bid offered in this auction is subject to sanction of the competent authority. The highest successful bidder will be required to deposit the total amount of the bid offered by him at the fall of the Hammer in Cash or in the shape of Demand Draft duly pledged to DPO(IDP), Sirmaur at Nahan. TDS and all other taxes applicable from time to time shall be deposited by him within seven working days from the acceptance of the bid.
- xv). Earnest Money of the successful bidder will be adjusted in the bid - amount. In case of failure to deposit the final outstanding balance amount of bidding by the successful bidder, the respective Vehicle will be again taken up for re-auction.
- xvi). The Vehicle will be allowed to be taken when the sanction from the Competent Authority is received. Merely being the highest bidder does not confer any right whatsoever arising as a result of this auction.
- xviii). Delivery of the Auctioned Vehicle shall be arranged only after the successful bidder submits documentary evidence in support of the residential status (PAN Card, Aadhar card, GST No. etc. in case of Individual and Registration Certificate etc. in case of Firms) along with all the outstanding balance amount pertaining to the Auction -Sale of the Vehicle. GST on the Sale/Bid amount will be charged @ 18% (9% as State GST and 9% as Centre GST) as per Rules and rates applicable from time to time.

xix). The Auctioned Vehicle shall have to be removed by the successful bidder within 7 working days of depositing the bid amount and receiving the sanction of the competent authority at their own expenses by way of either submitting the R.T.O. transfer Papers or cut chassis no. of the vehicle.

xx). The Vehicle sold will remain at purchaser's risk from the date of auction by the Competent Authority.

xxi). The successful bidder will also be responsible for getting Registration Certificate of the Vehicle and/or any other document/s required by the RTO in his name at his own cost within seven working days of depositing the bid amount. This department will not owe any responsibility for transfer of the Vehicle and for any other liability for using this Vehicle for commercial or any other purpose after sale/transfer of the Vehicle.

xxii). This Office will not be responsible for any lapse on part in this regard.

xxiii). If the successful bidder wants to scrap the vehicle, he should submit the cut part of the chassis no. to this office immediately, within seven working days of depositing the bid amount.

xxiv). The undersigned reserves the rights to accept or reject any/all of the quotations without assigning any reason.


xxv). All the cases of dispute, Departmental or legal, if any will be subject to the jurisdiction of Nahan only.
