- b) The interested bidder must be registered with Integrated Development Project H.P Forest Department as a contractor and he may consult the o/o under mentioned for any details as the case may be.
- c) The bids of the contractors/firms who fail to fulfill the eligibility criteria will summarily be rejected. Similarly, if the technical bid is not found suitable at the time of scrutiny by the tendering committee, the bid shall be rejected and thus their financial bid shall not be considered.
- d) Entire tender process will be carried out online through above mentioned website. Contractors /firms are advised to procure e-token/digital signing certificate from suitable venders or from any authorized
- e) Before submission of on-line bids, bidders must ensure that scanned copies of all necessary documents
- f) All the sampling and testing are to be done by the contractor with the help of field staff of HPIDP as per the prescribed CPWD or PWD. No extra cost will be given for the same.
