### **NOTICE INVITING E- TENDER**

Government of India has received a credit from the International Bank for Reconstruction & Development (IBRD) and International Development Association (IDA) towards the cost of the Integrated Development Project (IDP) for source sustainability and climate resilient Rain-fed-Agriculture and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations are issued.

Online bids on item rate basis are invited by the District Project Officer, Integrated Development Project, Kangra at Dharamshala, HP, through electronic tendering system on **www.hptenders.gov.in** under two covers system for the execution of under mentioned work . Bidder should be the eligible registered contractor in Integrated Development Project for Source Sustainability and Climate Resilient Rain-fed-Agriculture H.P. or registered with State Govt. / State Govt. Undertakings, who have experience in Construction of similar type of work and have established organization for taking up such work in hand who satisfy the qualification criteria of bid documents need only apply. In case successful bidder is not registered with HP IDP Project then the successful bidder should qualify and get himself registered in appropriate class with HP IDP Project before the award of Work.

**Conditions:-**

The –tender documents shall be uploaded in two covers system.

Cover-I shall contain scanned copies of “Eligibility information and Technical Bid”. Cover-II shall contain “Financial Bid” on the prescribed form.

Cover-I:- The “Eligibility information and Technical Bid” shall contain scanned copies of following documents duly uploaded in the bid:

- a) The intending bidders are required to pay the non-refundable tender form fee (INR 500/-) in form of demand draft payable at SBI Dharamshala or through e-challan to District Project Officer, Integrated Development Project, Kangra at Dharamshala D.D. Code 985 Treasury Code : KNG00 in the revenue Head 0070-60-800-17 E Procurement of Tender Fee. The scanned copies of it shall be uploaded under cover-I & the original documents shall be submitted physically on or before prescribed date.
- b) The intending bidders are required to pay the refundable EMD/bid security in the form of TDR/FDR from a commercial bank separately pledged in favour of District Project Officer, IDP, Kangra at Dharamshala, HP. The scanned copies of it shall be uploaded under cover-I & the original copies shall be submitted enclosed with the bids.
- c) Uploading of scanned copy of PAN and offline submission with cover-I.
- d) Uploading of scanned copy of GST registration and offline submission with cover-I.
- e) Uploading of scanned copy of EPF Registration Certificate and offline submission with cover-I.
- f) Uploading of scanned copy of registration with Integrated Development Project H.P Forest Department and offline submission with cover-I. Uploading of scanned copy of Income Tax & Turnover of last two years at least Rs. 50 Lakh in each year, It shall be certified by a Chartered Accountant and offline submission with cover-I.
- g) Uploading of scanned copy of Bank details of the bidder mentioning Name of the Bank, Branch Name, Account Number, IFSC, etc. and offline submission with cover-I
- h) Uploading of scanned copy of undertaking (Format attached in Tender Document) that I have carefully studied all the terms and conditions stipulated in the contract document before quoting the rates in the BOQ chart and also visited the site of work before quoting the rates and offline submission with cover-I.
- i) Uploading of scanned copy of authorization letter regarding digital signature certificate (DSC) of the person authorized by the registered tenderer.

Cover-II: Shall contain BOQ where contractor will quote his offer for each item in figures and words (INR) by giving total amount of the offer. Contractor shall not insert any additional conditions or other documents in BOQ.

**General Instructions for e-tendering:-**

- a) The contractor should register himself on website [www.hptenders.gov.in](http://www.hptenders.gov.in) and obtain user ID, password, before bidding.
- b) The interested bidder must be registered with Integrated Development Project H.P Forest Department as a contractor and he may consult the o/o under mentioned for any details as the case may be.
- c) The bids of the contractors/firms who fail to fulfill the eligibility criteria will summarily be rejected. Similarly, if the technical bid is not found suitable at the time of scrutiny by the tendering committee, the bid shall be rejected and thus their financial bid shall not be considered.
- d) Entire tender process will be carried out online through above mentioned website. Contractors /firms are advised to procure e-token/digital signing certificate from suitable vendors or from any authorized agency.
- e) Before submission of on-line bids, bidders must ensure that scanned copies of all necessary documents have been uploaded with the bid.
