- 5. You will have to deposit EPF and ESI as per applicable rates and submit the report to this office
- 6. It may be ensured that items of work for which you have quoted low rates be got executed in full.
- 7. The execution of work and its quality control shall be carried out strictly as per specification and as per instructions of APO/Project Staff.
- 8. All other condition of the tender document will be applicable.
- 9. The work will be executed under the supervision of FEO and any other authorized officer.
