5. Quotations, both Technical Part and Financial Part shall be submitted on [www.hptenders.gov.in](http://www.hptenders.gov.in) on or before 17 hours on 20<sup>th</sup> August, 2022 (*date*). Any quotation or modifications to quotation received outside e-procurement system will not be considered. The electronic bidding system would not allow late submission of quotations. The 'Technical Part' of the Quotations will be opened online on 22<sup>nd</sup> August, 2022 (*date*) at 16.00 hours<sup>2</sup>, this can also be viewed by the bidders online. The electronic summary of quotation opening of technical part will be generated and uploaded online.
