TERMS AND CONDITIONS' FOR THE PROCUREMENT OF WORKS, AS PER THE TENDERS/BIDS INVITED BY THE DISTRICT PROJECT OFFICER, (IDP) SIRMAUR AT NAHAN

Invitation of Tenders/Bids: The tenders/Bids are invited for the 'procurement of WORKS. The details of the items proposed to be procured including item-wise amount c 'Earnest Money Deposits', are as per the 'Tender List' attached with this 'Tender Notice'.

1. Instructions to bidders

- 1. Scope of Works: The scope of work is as per the schedule of quantity attached / supplied with the prescribed W-5, containing schedule of quantities. The details of works is tentative, which may vary depending on the geographical conditions/terrain of the area; and thus bidder(s) is (are) advised to visit the site of works, prior to bidding for said work at his own
- 1.1. Qualification Information to be provided by the Bidder: the bidder shall provide information on his qualification which shall include:-
 - (a) Total monetary value of works executed by him for each year of the last 3 years;
 - (b) List of works (similar to the works described in tender notice) completed satisfactorily as a prime contractor during the last 3 years, enclosing certificates from the respective Employers in support of experience claimed along with the Employers' contact numbers;
 - (c) Report on his financial standing, along with last 3 years' financial statements/Profit and Loss Statements; and current balance in account should not be less than the estimated cost of work.
 - (d) Details of any litigation, during the last 3 years in which the bidder is involved, the parties concerned, and disputed amount or award in each case(Give details of both completed and pending cases).

The bidder shall provide qualification information at the time of submission of quotation form on standard W-5(Schedule of quantity), which shall include:-

Self Attested copy of his/her PAN card.

Self Attested copy of the Bank Account duly covered under RTGS/NEFT.

Self Attested of GST/EPF numbers.

- 1.2. Qualification Criteria:to qualify for award of the contract the bidder:-
 - (a) Should have satisfactorily completed as a prime contractor at least one similar work of value not less than 80% of the estimated cost in the last three years;
 - (b) Should possess valid electrical license for executing building electrification works (in the event of the works being sub-contracted, the sub-contractor should have the necessary license);
 - (c) Should possess required valid license for executing the water supply/sanitary works (in the event of the works being sub-contracted, the sub-contractor should have the necessary license);
- 2. Eligibility Conflict of Interest: A Bidder (a) shall not participate in more than one Quotation; (b) shall not have conflict of interest as defined in the Bank's Procurement Regulations/ Guidelines [select one of the two options]; and (c) should not have been (i) temporarily suspended or debarred by the World Bank Group in compliance with the Bank's Anti-Corruption Guidelines and its Sanctions Framework; or (ii) blacklisted or suspended by Central or any State Government Departments in India.
- 3. Purchase of Bid Documents: The online tenders can be submitted by paying cost of document through DD drawn in favour of District Project Officer, (IDP), Sirmaur at Nahan, payable at any scheduled bank at Nahan and the scanned copy of the same be uploaded with his/her Tender/Bid. Whereas, the original DD shall have to be submitted by the Bidder in the office of the Undersigned on or before the date and time fixed for opening of Bids/Tenders. Tenders/Bids received without paying the cost of Tender documents in the above manner shall not be considered.
- 4. Earnest Money Deposit (EMD): In the case of e-tenders (online), bidders shall have to upload scanned copies of the FDR/TDR/CDR(duly pledged in favour of DPO(IDP)Sirmaur at Nahan) of equivalent amount of the EMD mentioned in the Tender Notice against each item. Whereas, the original FDR/TDR/CDR shall have to be submitted by the Bidder in the office of the undersigned on or before the date and time fixed for opening of Bids/Tenders. The tender(s) not accompanied by full amount of earnest money shall not be considered. The EMD, if deemed necessary by the competent authority, can be increased at the time of opening of tenders. The contractor/bidder who has/have uploaded scanned copy of FDR/TDR/CDR as EMD, DD as cost of tender form and other documents should deposit the original copies of the same in this office before the stipulated date and time. The contractor who uploaded desired documents on the website, but failed to submit the same physically, shall be debarred for further participation in the tender process in IDP in future.
- 5. Submission of Bid Documents/ Bids Price: The interested bidders are advised to carefully peruse the terms and conditions laid down for the procurement of works and also to visit the site of works at his own expense, in order to obtain all information that may be necessary for preparing his/her Bid document.
 - 5.1 The tender documents complete in all respect including required EMD should be uploaded on or before 16.08.2022 up to 5.00 PM and physically received in the office of the DPO (IDP), Nahan on or before 17.08.2022 up to 11.20 AM.
 - 5.2 The Bidder/Supplier shall quote his rate(s) including of all kind of Taxes, levies etc payable on the item of work and nothing extra shall be payable to the contractor on this account.
 - 5.3 The work quantity is tentative and may vary as per the actual requirement and availability of funds.
 - The bidder shall furnish complete address and all other information about himself/herself by filling in required information in the relevant lines/ space provided in Tender/Bid FORMAT/BoQ.

- The Bidder shall have to quote his price both in figures & words, which should be clearly legible and the Tender/Bid containing illegible, doubtful or 5.5 dubious figures may not be considered.
- 5.6 The Bidder shall Bid for the whole Quantity and for all components of the works under each item of works as described in the Tender/Bid FORMAT.
- All duties, taxes and other levies payable by the contractor as under rule, should be included in his total quoted price and same shall be deducted from 5.7 the bill of the contractor and nothing extra shall be paid to him/her on this account.
- Validity of Bid / Tenders: The Rate(s) quoted by the successful bidder in his/her Bid document shall remain valid 31.8.2022; and incase, if for any reason the rates for procurement of works could not be approved before the expiry of the stipulated period, the above quoted rates shall be deemed to remain valid/ enforced over an extended period up to the date of approval of the Tenders/Bidsinvited by this office for the procurement of same during the next Financial Year
- Submission of Bids /Tenders: The interested bidders are advised to ensure that the Bids/Tenders are submitted before the expiry of the stipulated period in the desired manner and the Bid/Tender documents including required EMD, should reach in this office before the expiry of the last date and time fixed for submission of Tender /Bids.
 - The bidder(s), in token of accepting / agreeing to the 'Terms and Conditions' of the Tender Notice, shall append his/her signature on each page of the 'Terms and Conditions' of the Tender Notice, including appending signature on the certificate from the bidder recorded in the box at the last page of this Notice and shall submit/attach the same with his/her Bid document.
 - The Tender document complete in all respect including required EMD must reach in the office of the District Project Officer, IDPSirmaur at NAHAN H.P.-7.2 173001, not later than the time and date specified in this letter of invitation of Bids.
 - 7.3 Each bidder shall submit only one Bid for each 'item' on standard Bid Format/document/BoQ
 - The bidder/contractor shall furnish complete address and all other information about him/her, in the relevant space provided in Tender/Bid Format
- Opening and Evaluation of Bids :All the Tenders/Bids received in this office shall be opened and evaluated in the office of the Undersigned by the 'Tender/Bid 8. Opening and Evaluation Committee' as per the schedule notified in the letter of invitation of Tenders/Bids.
 - The Bids/Tenders received after the expiry of the Schedule for its submission or received without required EMD shall not be considered.
 - The Bids/Tenders, not received on prescribed 'Tender Document' (Tender/Bid Forma/BoQ) or/and are incomplete, shall not be considered. 8.2
 - 8.3 The Conditional Tenders/Bids or the Tenders/Bidsreceived through fax or E-mail, shall not be considered.
 - Submission of false information(s) and/or document(s), bid with overwriting/incomplete financial detail(i.e. amount in words and figures not 8.4 mentioned) shall automatically lead to cancellation of the Bid/Tender of the Bidder and such cancellation of the Bid/Tender shall not prejudice any criminal proceedings that may be initiated against the bidder. Increase/decrease on total amount will not be allowed/acceptable.
 - 8.5 The Bids/Tenders 'Opening and evaluation Committee' will evaluate and compare only those Bids/ Tenders which have been determined to be responsive by the committee.
 - All the Bids/Tenders received before the expiry of scheduled time and date specified in the tender notice, shall be opened and evaluated by the 8.6 committee and a comparative chart/statement shall be drawn to select the Lowest Bidders. The Bids would be evaluated for all the works items
 - 8.7 The Bids would be evaluated for each item of work, separately.
 - To determine the lowest bidder in respect of item for execution of works, as per unit rates quoted by the bidders for all sub-items of work shall be added 8.8 and the lowest total rate so arrived by adding all the per unit rates, shall be considered as the Lowest(L-1).
 - After completion of the 'opening and evaluation' process, the EMD of all other unsuccessful bidder shallbe returned to them under proper receipt on the Register. Whereas, the EMD of the successful bidder(s) shall be converted in to 'Performance Security' or shall be retained by this office until the required Performance Security as laid down in the following clauses, is deposited by the successful bidder in the desired manner,

The information relating to evaluation of Bids/Tenders and recommendations of the 'Committee' shall not be disclosed to the bidders or any other persons not officially concerned with the process until the award to the successful bidder is announced.

The performance Security will be released after six months, or one full monsoon season whichever occurs later from the date of completion of awarded contract strictly as per the 'Terms and Conditions' of this notice and after due verification/ recommendation by the concerned APOs.

Period of Maintenance:

The "Period of Maintenance" for the work is six months from the date of taking over possession or one full monsoon season whichever occurs later. During the period of maintenance, the contractor will be responsible for rectifying any defects in construction free of cost to the Employer

- 9.1 The bidder, whose bid/Tender has been accepted, may prior to expiry of the validity period be notified about acceptance of his/her bid and he/she shall have to complete all the codal formalities including signing of agreement deed before award of contract.
 - We reserve the right to execute any part of the item of work or whole work, put to tender and the contractor shall not have any right to object to it. 9.2 The bidder whose bid has been accepted and has deposited the required performance security in the desired manner and has also signed the agreement deed, may be notified of the award of contract prior to expiry of the validity period.
 - The terms of the accepted offer shall be incorporated in the award of work. 9.3
 - In case of 'tie' between or among the 'Lowest bidders' in their quoted rates, the work shall be awarded to one of them on the basis of lottery/toss system. The quantity of the above work is tentative and may vary as per the actual/site requirement and availability of funds. The Contractor shall have 9.4 no right to object or challenge the decision of the Undersigned.
 - The quantity of the above work is tentative and may vary as per the actual/site requirement and availability of funds. The Contractor shall have no 9.5 right to object or challenge the decision of the Undersigned to this effect.

9.6 The contractor/ bidder shall have to complete the work within the stipulated period & at the agreed costs and nothing extra shall be payable on account of escalation of cost for whatever reasons in due course of time. 9.7

The DPO(IDP)Sirmaur at NAHAN may allow extension of the period for completion of allotted workon written request of the Bidder stating

reasons/grounds for seeking additional time.

9.8 In case, contractor falls to start the awarded work within the stipulated time, the award of work is liable to be cancelled and besides forfeiture of the security of the contractor, execution of work may be carried out either through any other contractor or the work is taken up by us at the risk and cost of

The successful bidder(s) will have to complete the allotted work within the stipulated period and in case the contractor abandons the work in 9.9 between or there is inordinate delay in its execution to the extent when Undersigned is convinced that contractor will not be able to complete the work within a stipulated period, under such situation Undersigned shall have the right to take over and complete the remaining work at the risk and cost of the

contractor and shall also attract penal provisions of this notice as laid down in following clauses.

- 9.10 If the successful bidder fails to complete or start the allotted work within stipulated period, a penalty @ 0.1% per day, of the Total Value of the awarded work, rounded off to next hundred, shall be charged from the Contractor up to next 15 working days. The penalty after 15- working days shall be charged at the enhanced rate of 0.5% rounded off to next hundred, per day of the Total Value of the awarded work, till the work is either completed by the contractor within the additional time allowed to him/her on his written request stating reason for such extension or the allotment of work is cancelled to complete the work/ remaining work at the risk and cost of the contractor either through other contractor or through some other efficacious manner.
- 9.11 In case, the amount of recovery exceeds the dues of the bidder, we shall have the right to effect the recovery of the remaining outstanding amount from the contractor by way of recovery of Revenue arrears or through other available means as per law of the land.

No advance payment will be made to the contractor. However, Contractor shall be paid 80% of the work done amount and 20% amount shall be paid 9.12 after successful completion of the awarded work.

9.13 The contractor/bidder also shall have to bear all the taxes, levies, charges etc., as applicable or Taxes/charges levied by the Govt., in due course of time and the 'Income Tax', 'Work Contract Tax' and any other Tax as payable under rule will be deducted from the bill of the contractor. The contractor/bidder also shall have to bear all other applicable taxes, charges, contributions towards labour welfare etc., not listed in this notice separately or Taxes/charges levied by the Govt., in due course of time.

The contractor shall be responsible for any loss or damage caused directly or indirectly, to the property of the project, and shall be bound to pay for such 9.14 loss/damage.

- In case of breach of any condition of the Tender Notice for which no specific provisions have been made in this notice, a penalty not exceeding 9.15 Rs.5000/- may be imposed for every such breach. However before imposing such penalty, the Contractor will be given an opportunity for explaining his position. The decision of the undersigned in this regard will be final and thereafter, no correspondence/objection will entertained.
- The forfeiture of performance security for breach of 'Terms and conditions', or non completion or not starting execution of allotted work within stipulated 9.16 period, shall not prejudice any other just and proper action against the Contractor.
- The successful Bidder shall have to engage his own labour, trucks, tools, and machinery etc., for completion of allotted work. 9.17 In case the contractor has been asked to provide required material, he/she shall have to purchase all the construction material of the required standard technical specifications and the contractor/bidder will have to produce the original bills in support of the procurement of B/Stone, Stone aggregate, Sand, Cut stone, Steel, Bricks, B/Wire, U/Stapples, Fence Posts etc with his bill/claim for payment of his dues/charges or the amount of royalty, as applicable, will be deducted from the final payment of the contract / work.
- The contractor / bidder shall pay the minimum wages to the labourers and also shall comply the provisions of all applicable labour laws or as may be 9.18 notified/amended by the State Government from time to time and he/she shall be bound to abide by the Industrial Dispute Act 1947 and other labour/ welfare laws enacted from time to time by GOI/GHP.
- The contractor will submit a list of the workers/majdoors engaged for the execution of allotted work 9.19 within 7-days of the start of work.
- The contractor shall also be responsible to submit a list of change/replacement of the workers/ majdoors, either disengaged or newly engaged by 9.20 him/her from time to time, within 7-days of each change/replacement.
- The Contractor(s)/Labour Supply Mate(s) is/are required to Registered himself/ themselves under the Labour Contract Act,1970 and HP Contract 9.21 Labour (Regulation & Abolition) Ruls-1974 from the Labour officer & shall produce the copy of the same to the Undersigned within three months of the date of issue of award of work.
- The Contractor/Labour Supply Mate(s) is/are required to obtain license under the Labour Contract Act, 1970 & Inter State Migrant Workmen (Regulation 9.22 of Employment & Conditions of Services Act, 1997 from the Labour Officer & shall produce the same to the Undersigned within three months of the date of issue of
- The Contractor shall enroll for an independent E.P.F number under the employees provident fund scheme and will remit E.P.F. of labour and his share 9.23 along with administrative charges to the E.P.F. authorities, at the prevailing rates as per rules/act in vogue. However, contractors who do not have EPF Number can also participate in the tender but he shall have to register him/herself within 3 months, with the concerned authority and the Undersigned shall have the right to deduct the amount of provident fund as applicable and shall be deposited with the concerned authority.
