


1 (b) The contractor shall have to abide by all the rules of enlistment as contained in the "Rules of Establishment of contractors in IDP, 2020" and as amended from time to time and also by the terms and

conditions of the contract and the Notice inviting tenders.

2. All other terms and conditions as envisaged in Office Order No.IDP /2020/33 dated 04/06/2020 issued by the Chief Project Director, IDP Solan (HP) will applicable for enlistment / revalidation of the contractors.
