2. SOURCE OFFUNDS

Government of India has received a credit from the International Bank for Reconstruction and 2.1 Development (IBRD) equivalent to USD 100 million towards the cost of the Integrated Development Project for Source Sustainability and Climate Resilient Rain Fed Agriculture, H.P. Payments by the Bank will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the financing agreement. The financing agreement prohibits a withdrawal from the credit account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security council taken under Chapter VII of the Charter of the United Nations. No party other than the Borrower shall derive any rights from the financing agreement or have any claims to the proceeds of the credit. 3.

5. TENDER EVALUATION

- The Pre-qualification cum Technical Bid will be opened and evaluated on 3rd May, 2023 at 11:30 am in the chamber of the District Project Officer, IDP Una, H.P. in the presence of the Bidders or their Authorized Representatives, whosoever would like to be present.
- 5.1.2 Following scrutiny, Financial Bids of technically qualified Bidders will be opened on the same day in the chamber of the District Project Officer, IDP Una in the presence of the Bidders or their Authorized Representatives, whosoever would like to be present,

- 5.1.3 After technical scrutiny, analysis, evaluation and comparison a comparative statement shall be drawn to find out the lowest and outmost advantageous bid. The successful Bidder i.e. Supplier shall be then issued the acceptance letter for execution of agreement. On execution of agreement award letter shall be issued to successful bidder after depositing performance security.
- 5.1.4 Bidders are expected to carefully examine all instructions, PERFORMA's, terms & conditions and specifications in the Tender Document. PERIOD OF VALIDITY OFQUOTATIONS 11

- 11.1 Quotations shall remain valid for the period stated in Table 1. A Quotation valid for a shorter period shall be rejected by District Project Officer, IDP Una as non responsive.
- 11.2 In exceptional circumstances, prior to the expiration of the Quotation validity period, District Project Officer, IDP Una may request Bidders to extend the period of validity of their Quotations. The request and the responses shall be made in writing. A Bidder may refuse the request. A Bidder granting the request shall not be required or permitted to modify its Quotation.

DEADLINE FOR SUBMISSION OF QUOTATIONS 12

- 12.1 Quotations must be received by District Project Officer, IDP Una at the address and no later than the date and time indicated in Table 1.

LATE QUOTATIONS 13

13.1 District Project Officer, IDP Una shall not consider any Quotations that arrive after the deadline for submission of Quotations, in accordance with Table 1. Any Quotation received by District Project Officer, IDP Una after the deadline for submission of Quotations shall be declared late, rejected, and returned unopened to the Bidder.

AWARD OF CONTRACT 14

District Project Officer, IDP Una shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated Quotation and is substantially responsive to the Quotation Document, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.

Prior to the expiration of the period of Quotation validity, District Project Officer, IDP Una shall notify the successful Bidder, in writing, that its Quotation has been accepted.

At the same time, District Project Officer, IDP Una shall also notify all other Bidders of the results of the bidding. District Project Officer, IDP Una will publish in its Notice Board and website the results identifying the Quotation and lot numbers and the following information: (i) name of each Bidder who submitted a Quotation; (ii) Quotation prices as read out at Quotation opening; (iii) name and evaluated prices of each Quotation that was evaluated; (iv) name of Bidders whose Quotations were rejected and the reasons for their rejection; and (v) name of the winning Bidder, and the price it offered, as well as the duration and summary scope of the contract awarded. Within twenty-eight (28) days of receipt of the Contract Agreement, the successful Bidder shall sign, date, and return it to District Project Officer, IDP Una.

15 TERMS AND CONDITIONS

- 15.1 The bidder should quote monthly rates inclusive of all charges i.e. fuel, repair, driver charges etc. The bidder shall quote the fixed rates for 1500 kms. Per month and rate per km. beyond
- 15.2 The vehicle will be required on 24 hour basis/on call basis and no extra charge will be paid for late journey and night halt with in state or outside headquarter.
- 15.3 All type of repair shall be carried out by the Contractor at his own cost for which the vehicle will be spared for three days in a year.
- 15.4 The contractor shall keep and maintain a log book with the vehicle after getting it authenticated from project authority. The Project staff will verify the journey in the log book. The logbook has to be verified from DPO, IDP, Una on monthly basis on the abstract prepared. The logbook will be the property of project and shall has to be deposited in the o/o undersigned in case of completion/cancellation/termination of contact.
- 15.5 The vehicle shall be treated as an official vehicle of the Project. No private journey/use as taxi will be allowed during the contract period.
- 15.6 In case of any breakdown, the contractor will provide substitute vehicle immediately, otherwise a penalty of Rs. 1000/- per day will be imposed and the recovery of the same will be made from the monthly running bill of the vehicle.
- 15.7 Project will not pay for lubricants/ coolants/ grease/ POL etc.
- 15.8 All the journey performed, covered on account of filling of fuel/ repair and cost incurred by the driver during his halt at out station/ at headquarter from his residence/ place of parking to place of duty shall not be paid by Project.
- 15.9 Project shall have the right to deduct taxes/TDS/Bank charges etc. at source as applicable as per rules in force from time to time.
- 15.10 The contractor of the vehicle shall be responsible for compensation payable arising out of accident payment to third party, if warranted. No compensation in case of accident/ damage

- to vehicle or for death/ injury to the driver will be made by Project.
- 15.11 In case of loss of property of Project is caused due to the negligence on the part of the driver of the vehicle, such losses shall be borne by the contractor.
- 15.12 On all working day, the driver along with vehicle shall remain available in the office premises of DPO, IDP, Una or the place where duty is assigned. On all the remaining hours of the day and on non-working days too, the vehicle shall be made available within half hour of the call for all the 24 hours of the day.

 15.13 Driver deployed on well the day.
- Driver deployed on vehicle should have a mobile phone with a local number for better coordination. The cost/ expenditure on this account shall be borne by the contractor. Switching of mobile or non-response to phone call by driver (either on Mobile or on local number) would be treated as non-availability of vehicle and penalty of Rs. 1000/- per day would be imposed and recovery of the same will be made from the monthly running bill.
- The driver with a valid driving license, for commercial vehicle, shall be provided by the owner of the vehicle and salary as well as other facilities to him shall be paid/ borne by the owner. In no case the driver will be allowed to be replaced without prior approval of the Project. As per office requirements the vehicle is required to ply within or outside the State. So all the paper formalities like tax deposit, insurance, pollution check, road permit, toll tax etc. should be cleared in all respects by the owner of the vehicle. The driver deployed should have appropriate character verification from the Police.
- 15.15 The vehicle shall have two sets of loose white seat covers for alternative use and shall be changed weekly. Cost of cleaning of the same will be borne by the contractor.
- 15.16 Photocopies of the documents i.e. Registration Certificate, valid insurance, tax clearance certificate and valid taxi number issued by the competent authority should be submitted along-with the Tenders and in case of award of contract the same may be got renewed from time to time.
