ELIGIBILITY CRITERIA FOR PARTICIPATING WUGs and PGs (WUGs/PGs)

To be eligible for consideration for receiving MG, WUG/PG under the window for groups should meet the following minimum criteria*:

- 1. Groups should be either formed or strengthened under the Project. Consideration will also be given to high potential groups not formed under the project, but which are operational inthe project area, if the grant objective aligns with the PDO.
- 2. Itshouldbefunctional, ascertifiedbythelocalfacilitating team(comprisingfrontline staff
- 3. Itshould haveatleast5activemembers (notmorethan onememberfromany household)
- 4. Well function WUGs/PGswillbeconsideredforgrantseveniftheyhavereceived similar grants from other sources previously.
- 5. It should have an Aadhaar- linkedbank account in a public sector bank, in the name of the WUG/PG with two/ three signatories. in case appropriate banking facilities are not available inthePanchayatarea,theaccountmaybeopenedwithanyotherbank operating in nearby area,with priorapprovalfromtheconcerned DPO.
- 6. Each WUG willdepositinitsownaccountanupfront shareof 5% of theetotalcostofthe assets towards O & M. In addition, groups will also contribute to the GP level OMIF account, equivalent to 1 % of the total cost of asset/ work granted.
- 7. Group will submit a Business plan with detailed costing and specification for the use of grant, money.
- 8. New applicants with strong proposals but who have not received any support will be proffered
- It may be noted that application does not guarantee receipt of grant, there will be a process of evaluation and prioritization of applications before grantees are announced. Group Grants will range from INR 40,000 to INR 1, 50,000 /- pergroup; on average, INR 3 lakhs is allocated per participating GP.

CRITERIA FOR PRIORITIZATION OF APPLICATIONS FROMWUG/PGs

- 1. Women/s Groups or groups led by women.
- 2. Predominantly vulnerable HH members (> 70%)
- 3. Groups with member's land in contiguous patch
- 4. More members having contributed upfront
- 5. Clarity of costs, benefits and cost sharing norms among users, and between WUG and IDP
- 6. Applications with plans which are better aligned with the project objectives

7. Implementable in a shorter time span (6 months to 1 year receive highest priority)

ELIGIBILITY CRITERIA FOR PARTICIPATING INDIVIDUALS

To be eligible for applying for a MG under the window for individuals, a person should meet the following minimum criteria*:

- 1. Ordinarily a resident of a GP included under the Project (male or female)
- 2. A farmer (own land, sharecropper, leased land etc.)
- 3. At least 18 years of age
- 4. Applicants should be able to produce evidence of land ownership, viz., Tatima, Jamabandi, Nakal, etc./Copy of lease agreement/ ownership of animals (Registration certificate)/any other certificate as per Government guidelines; such land should also be in possession of the applicant/s, and free of any ownership conflict/s
- 5. Aadhaar-linked bank account in a scheduled bank, held by the beneficiary.
- 6. Clear articulation of plan for use of grant money.
- 7. New applicants with strong proposals but who have not received any support will be preferred
- It may be noted that application does not guarantee receipt of grant, there will be a process of evaluation and prioritization of applications before grantees are announced. Scale of Grant would be up to a maximum of INR . 30,000 /- per individuals.

- 7. Households mentioned in Socio Economic and Caste Census (SECC) Report
