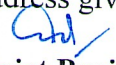

Bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the above website.
4. Quotations, both Technical Part and Financial Part shall be submitted on <https://hptenders.gov.in/> on or before 11:00 hours on 24-07-2025. Any quotation or modifications to quotation received outside e-procurement system will not be considered. The electronic bidding system would not allow late submission of quotations. The 'Technical Part' of the Quotations will be opened online on 24-07-2025 at 12:30 hours, this can also be viewed by the bidders online. The electronic summary of quotation opening of technical part will be generated and uploaded online.
