Government of India has received a credit in the US Dollars from the International Bank for Reconstruction & Development (IBRD) towards the cost of the Integrated Development Project for Source Sustainability and Climate Resilient Rain-fed Agriculture and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.

Online bids on item rate basis are invited by the District Project Officer, Integrated Development Project, Kangra at Dharamshala, HP on behalf of the Governor of Himachal Pradesh, through electronic tendering system on www.hptenders.gov.in under two covers system for the supply of Veterinary Medicines from the Registered manufacturers / Authorized distributors / dealers holding required eligibility criteria :

The bidders would be required to register in the web site which is free of cost.

Quotations, both Technical Part and Financial Part shall be submitted on or before 29.08.2025 at 11.00 A.M. Any quotation or modification, to quotation received outside e-procurement system will not be considered. The electronic bidding system would not allow late submission of quotations. The 'Technical Part' of the quotations, will be opened online on 29.08.2025 at 12.30 P.M. this cant also be viewed by the bidders online. The electronic summary of quotation opening of technical part will be generated and uploaded online.

Cover-I shall contain scanned copies of "Eligibility information and Technical Bid". Cover-II shall contain "Financial Bid" on the prescribed form.

Cover-I:- The "Eligibility information and Technical Bid" shall contain Scanned copies of following documents duly

uploaded in the bid

- a) The intending bidders are required to pay the non-refundable tender form fee (INR 500/-) in the shape of demand draft payable at SBI K B Dharmshala or through e-Challan to District Project Officer, Integrated Development Project, Kangra at Dharmshala D.D. PROCUREMENT OF TENDER FEE. The scanned copies of it shall be uploaded under cover-I & the original copies shall be submitted enclosed with the bids i.e cover-I.
- b) The intending bidders are required to pay the refundable EMD/bid security (INR 15000/-) in the form of TDR/FDR from a commercial bank separately pledged in favour of District Project Officer, IDP, Kangra at Dharmshala, HP. There shall be exemption to deposit earnest money to the firms - manufacturer register with H.P Controller for Store, Director General of Supplies and Disposals (DGS&D), Micro and Small Scale Enterprises registered with HP State Store Purchase Organization and HP State Undertaking subject to the condition that they have to quote the approved rates of above items with the organizations mentioned above. The scanned copies of its shall be uploaded under cover-I & the original copies shall be submitted enclosed with the bids.
- c) Uploading of scanned copy of latest ITR filed & GST return / clearance 2024-25 and offline submission with cover-I
- d) Uploading of scanned copy of registration certificate of having register with Veterinary / Health Department and offline submission with cover-I
- e) Uploading of scanned copy of Bank details of the bidder mentioning Name of the Bank, Branch Name, Account Number, IFSC, etc. and offline submission with cover-I
- f) Uploading of scanned copy of undertaking (Format attached in Tender Document) that I have carefully studied all the terms and conditions stipulated in the contract document before quoting the rates in the BOQ chart and offline submission with cover-I

Cover-II: Shall contain BOQ where contractor will quote his offer for each item in figures and words (INR) by giving total amount of the offer. Contractor shall not insert any additional conditions or other documents in BOQ.

General Instructions for e-tendering:-

- a) The contractor should register himself on website www.hptenders.gov.in and obtain user ID, password, before bidding.
- b) The interested bidder must be registered as a contractor and he may consult the o/o under mentioned for any details as the case may be.
- c) The bids of the contractors who fail to fulfill the eligibility criteria will summarily be rejected. Similarly, if the technical bid is not found suitable at the time of scrutiny by the tendering committee, the bid shall be rejected and thus their Financial Bid shall not be considered.
- d) Entire tender process will be carried out online through above mentioned website. Contractors /firms are advised to procure e-Token/Digital signing certificate from suitable venders or from any authorized agency.
 - e) Before submission of on-line Bids, Bidders must ensure that scanned copies of all necessary documents have been uploaded with the bid and its copies are physically submitted in this office before **12:00 AM** on dated **29.08.2025**..... Non submission or short of any document attached will be summarily rejected and financial bids will not be entertained
